TIMBERLAKE COUNCIL MEETING December 17, 2013

Mayor Cattani opened the meeting with the pledge to the flag at 7:30 PM. After the public portion, Mayor Cattani asked for the roll call of the officers.

The Mayor asked for a motion to approve the minutes for the November 19, 2013 meeting.

SAFETY

Jane Shaveyco reminded council that Ordinance 2013-6 was put on first reading, February 19, 2013. This Ordinance was to amend the salary of the Chief of Police and additional officers of the department. Ms. Shaveyco asked that this Ordinance be withdrawn. All of council was in favor of withdrawing this ordinance.

Acting Police Chief Esser took the floor to address the speed limit of the village. The police department has been cracking down on offenders issuing warnings, writing tickets and have stepped up patrol in certain hotspots. The Chief talked about the arrest of the driver charged with OVI over the Thanksgiving holiday.

Mr. Dicki asked about the speed on East Shore and if radar has been used as vehicles seem to go quite fast down East Shore. Chief Esser said that radar has been run and the average speed was around 23 mph.

FINANCE

SEWERS

Mr. Gasier said construction on Keewaydin has begun. The broken line was filled with clay and a new line is being run to the manhole on the street. A temporary patch will be used to get through the winter and a final asphalt patch will be put down in the spring.

The repair is being done by Eastside Plumbing and Sewer.

Requests for bids have gone out for the camera work to be performed in the storm sewer lines.

SERVICE

Mr. Zalar said that Scott has been doing a great job on the streets this winter. We will have seconded shipment of salt delivered this week.

Home owners must maintain high weeds, bushes, and trees at the ends of the drives and intersection so that clear vision is maintained. Those in violation will be contacted by letter. Replacement of new street signs is continuing. Please note new signage at different intersections will be coming do to the changes in state laws.

There was no hall report.

PARKS AND RECREATION

Mike Stanton stated that new trees are doing well. East Shore will be worked on next year for tree trimming.

Mike Stanton is looking into cost of repairing drinking fountain and also installing a hose attachment to the fountain.

Mike Stanton presented Ordinance 2013-49, an ordinance amending Ordinance 2012-21, placement of trash containers for pick up and declaring an emergency. This ordinance states:

- a) All rubbish, garbage and trash containers/receptacles shall be permitted to be stored along side of the home but shall be kept at a minimum, five (5) feet from the front of the home.
- b) Notwithstanding Section (a), all rubbish, garbage, and trash containers shall be placed on the curb at the tree lawn no sooner than 24 hours prior to the scheduled rubbish, garbage and trash collection, and shall be removed within 24 hours following such collection.

Mr. Stanton presented Ordinance 2013-48, an ordinance renumbering section 700.10, Placement and Storage of Trash Containers, and declaring an emergency. 700.10, Placement and Storage of Trash Containers, is currently located under Chapter 700, Local and General Offenses Provisions. Whereas, said Codified Ordinance has a Chapter 1060, Garbage and Rubbish Collection and Disposal, and therefore it would be best for Section 700.10 to be relocated under Chapter 1060 for easy accessibility. Section 700.10, Placement and Storage of Trash Containers, is hereby renumbered to read 1060.01.

It has been found that no filing fee was ever established for an Appeal filed with the Board of Zoning Appeals. It is in the best interest of The Village of Timberlake to establish said filing fee to offset the costs associated with the processing of an Appeal of the Board. 12403.03 Appellate Procedure – "There shall be a filing fee of Fifty Dollars (\$50.00), with the check made payable to The Village of Timberlake, which shall be submitted with written Appeal Application to the Board of Zoning Appeals."

Mr. Stanton presented Ordinance 2013-51, an ordinance amending Section 1260.10, side yards, of the code of ordinances for The Village of Timberlake, and declaring an emergency. It is found that Section 1260.10 of the Codified Ordinances of The Village of Timberlake is outdated and needs modification.

Section 1

Section 1260.01, Side Yards, is hereby amended to read as follows:

"In the Residence District, for every building, there shall be a side yard along east lot line other than a street line or rear line, the least dimension of which shall be five feet. The side yards herein provided for shall be open for their full required dimensions from the ground to the sky, unobstructed, except for the ordinary projections of window sills, belt courses, cornices and other ornamental features, to the extent of not over six inches, heating or air conditioning, (ground or window units), trees and or property line bushes planted before the enactment of this Ordinance."

Section 2

It is found and determined that all actions of Council concerning and relating to the adoption of this Ordinance were so adopted in meetings open to the publid and Council and its committees acted in full compliance with Section 121.22 of the Revised Code of Ohio.

Section 3

This Ordinance is hereby declared to be an emergency measure necessary to the immediate preservation of the public peace, property, health and safety for the citizens of The Village of Timberlake, and therefore provided that the within Resolution received the requisite vote, it shall take effect and be in force after its passage; otherwise it shall take effect and be in force from and after the earliest period allowed by law.

Mr. Stanton explained that over the last year we have had numerous requests by residents with concerns over property lines, where the boundary lines are, etc. This year we had a property line dispute and Gary Gray went out to address the dispute. When Gary pulled out the old ordinance he found that the majority of the village is in violation of the current ordinance. The current ordinance states that there is a five foot set back and that nothing is to be in that set back. That includes trees, air conditioners, bushes, fences, etc.

We have a few options at this point. Gary would have to go out and site everybody in violation. That would cause months and months of residents going before the board of appeals and trying to get variances and easements or we can clarify and amend the ordinance from this date forward. This ordinance was never enforced as it was written.

This ordinance is left in first reading for additional consideration and clarification to go forward for the village. The original ordinance was written in 1957.

Mr. Dicki would like to keep Ordinances 2013-3 & 2013-4 in first reading to give the council people a chance to look further into these issues. These ordinances are for purchases in the different departments in the village. The first reading was February 19, 2103.

The mayor asked for a motion to adjourn. Motion made by Jane Shaveyco Seconded by Mike Stanton

The mayor thanked Jane Shaveyco for her four years on council. Tonight was her last meeting.

Roll call was done and all were in favor or adjourning the meeting.

TIMBERLAKE COUNCIL MEETING JANUARY 21, 2014

Mayor Cattani opened the meeting with the pledge to the flag at 7:37 PM. After the public portion Mayor Cattani asked for the roll call of officers.

Present: Sharma, Dicki, Stanton, Zalar

Absent: Gasier (excused)

The minutes for the December 17, 2013 council meeting are not ready. The council secretary had an emergency and was unable to have them prepared in time. The Mayor asked for a motion to approve the minutes for the January 13, 2014 special council meeting.

Mary Trepal was introduced as the newest member of council. She is filling the vacant term, which expires 12/31/17. Ms. Trepal and councilpersons Sharma, Dicki and Zalar were sworn in and contratulated.

Mayor Cattani discussed the recent notices regarding reporting income earned in the village. These were meant to create awareness that residents working from their homes should report that income as earned in the village. There is usually a tax advantage to the resident to do this, as well as a benefit to the village.

Mayor Cattani addressed the placing of three renewal levies on the May ballot. He noted that in the past decade, the residents have supported these levies by a nearly 3 to 1 vote, and he anticipated similar support this May.

Mayor Cattani presented his Annual Report to the Village:

2013 was a year of many changes in the village. Following the resignations of three council members, the village appointed Dennis Dicki, Ken Zalar, and Ritu Sharma to finish those terms, which all expired on 12/31/13. All three appointees were good fits, and seem to enjoy the opportunity to give back to the village. Mr. Cattani was thrilled that all three sought, and were elected to, new 4 year terms in the November election. Maintenance Inspector Ron Novinc resigned because of his demanding workload in his day job. The village was fortunate to find and hire Ruth Marshall to replace Mr. Novinc. In October, Geoff Esser was asked to immediately step into a very difficult situation, assuming the role of Acting Chief of Police. Geoff has really shown himself to be a stand up guy, throwing himself into the work. He has worked tirelessly to shape the department according to his vision and values, and has been aided by a core group of employees, including Michael Borne. Chad Thompson also went far beyond the call of duty in seeking out grants for the department.

The Service Department worked hard all year long. Scott Phillips, who came on board in 2012, has been a great hire for the village, and it is hoped that he stays with us for a long time. The village endured a tremendous rain event on July 20th, and Scott and several council people made themselves available to help put things back in order. The village spent significant funds in addressing issues in our aging system, and that program continues into the current year. We were not awarded any grant money for a planned road resurfacing, so that project was shelved.

We had another very successful playground program, with great attendance and great programming. The Village Club again hosted a variety of social events that foster the sense of community that defines the Village of Timberlake.

The village underwent our biennial fiscal audit last year, and received high marks. The Mayor thanked Jane Shaveyco and Lisa Stefaniak for the many hours they invested in preparing records for the audit, making the process efficient and cost effective. Overall, our finances remain challenging. In total, the village had revenues of \$538,000, and expenditures of \$569,000. There were roughly equal amounts of unanticipated expenses and unbudgeted income. We were also fortunate that some of the vacant properties were sold in 2013, as this should have a positive impact on both property tax and income tax collections. The BOPA should be commended for their work in resolving a dispute with Eastlake over sanitary sewer expenses, saving the residents \$25,000 dollars.

Moving into 2014, the Mayor's agenda is to push forward with improvements to the storm sewer system, street resurfacing and installation of sidewalks on Lakeshore Blvd. The village will aggressively pursue grant dollars for these projects, as well as for more new police equipment. Finally, the mayor extended his thanks to all elected officials for the hard work performed during 2013. He is thrilled to be working with such a cohesive and committed group.

We are hopeful that additional funding will allow for the purchase of a second MDT. This will allow us to pull drivers' license and vehicle info ourselves instead of relying on dispatchers.

VILLAGE HALL

Dr. Sharma reported that rentals are slow. Illuminated exit lighting will be installed in the hall this month.

TREES, PARKS, AND RECREATION

Mike Stanton announced that the trees that were planted last fall are doing well. No issues at the park.

Mr. Stanton placed ordinance 2013-51, as amended, on first reading. An ordinance amending section 1260.10, side yards, of the code of ordinances for the village of timberlake, and declaring an emergency.

Mr. Stanton scheduled hearings for two resident who have appealed Notices of Violation regarding the current side yard setback zoning ordinance. The hearings will take place at the Village Hall on Tuesday, January 28, 2013 at 7:30PM.

SERVICE

Mr. Zalar demonstrated the condition of the old traffic signs, as well as the reflectivity of the new signs, mandated to be installed by June. The village continues to install a few at a time, as weather permits. Discussion ensued about the need for and the appropriateness of stop signs at the ends of Nokomis, as well as plowing practices and use of road salt.
