## OUT OF THE PAST

---

*Timberlake was incorporated in October 1947, making 2017 our 70th birthday! To commemorate this event, Ron Mona has compiled a history of our Village. Check for a new installment each month.*

Timberlake's volunteer Fire Department came into being in 1955. A mutual aid agreement with Willowick provided fire protection. A used fire truck was purchased from Willoughby and children were given a free ride during the Summer carnival. In 1990, the fire truck was put up for bids and sold.



**RECENTLY COMPLETED** Timberlake Fire Station is located at the eastern end of Keewaydin Dr. It is staffed by a volunteer fire fighting force and a second-hand fire truck. Its purpose is merely for assisting the Willowick fire department in fighting Timberlake blazes. Timberlake has a mutual aid agreement with the larger village and its fire department is used only to supplement Willowick equipment. William Darroh is chief of the Timberlake department.

## FROM THE MAYOR AND COUNCIL

---

Dear Residents,

On August 27, 2012 Judge Eugene Lucci of the Lake County Court of Common Pleas rendered an Order Establishing the Natural Shoreline in case number 04CV001080. This order comes following remand from the Ohio Supreme Court to Judge Lucci to determine what is the "natural shoreline, which is the line at which the water usually stands when free from disturbing causes."

Pursuant to the Lucci decision, the property line is midpoint between the "farthest points landward and lakeward" that the water reaches, absent any disturbing forces such as storms or flooding.

In his Order, Judge Lucci undertook an extensive review of "disturbing causes" in order to determine the "natural shoreline" and the "water's edge when undisturbed." The final result is a boundary that is semi-static in nature yet will imperceptively move over time.

We are advising the Residents of the Village whom plan, or so happen, to walk the beach to be advised of this property line. Please note that walking along the waters' edge may actually put you on another Resident's property and subject you to prosecution for trespassing. If you have any question as to your legal rights in regards to the property lines along the waters' edge please consult an attorney.

This waiver and release is not only applicable to The VILLAGE of TIMBERLAKE SUMMER RECREATION PROGRAM but also waives any rights and/or claims against and forever discharges The VILLAGE of TIMBERLAKE, its agents, or representatives from any and all manner of claims, demands, cause of action or suites that the undersigned might now or hereafter have or that might subsequently accrue to the undersigned and by reason of any matter or thing whatsoever, and particularly growing out of any way connected with, directly or indirectly the undersigned's minor child(ren)'s voluntary participation or involvement in the VILLAGE of TIMBERLAKE RECREATION PROGRAM.

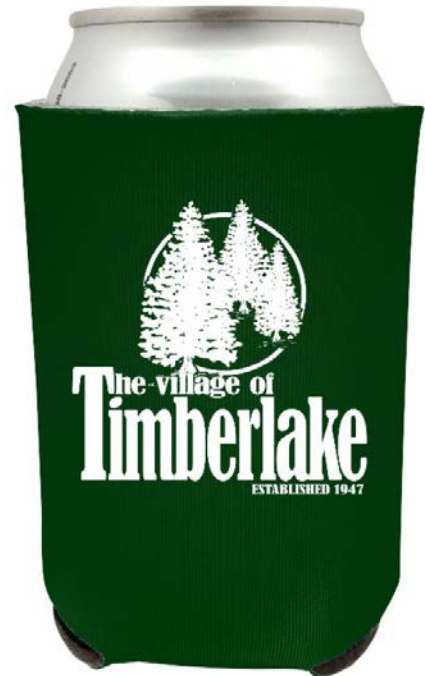
