TIMBERLAKE COUNCIL MEETING

October 20th, 2015

Mayor Cattani opened the meeting with the pledge to the flag at 7:35 PM. After the public portion, Mayor Cattani asked for the roll call of the officers. All council members were present along with our Solicitor and Mr. Roskos.

The Mayor asked for a motion to approve September 15th, 2015 Council Minutes.

Dicki made two changes to the Minutes; X was changed to 2 years and the date was changed to September 15th, 2015.

Motion to approve with changes and corrections: Gasier

Seconded: Parihar

Ayes: Dicki, Stanton, Parihar, Gasier, Sharma

Nays: None

Motion carried; Minutes approved.

The Mayor announced the appointment of Linda Murphy to the vacant council seat, introducing Resolution 2015-51

Motion to approve without changes or corrections: Stanton

Seconded: Parihar

All were in favor of the Resolution; Motion approved

Ms. Murphy was sworn in and congratulated on her new role.

SAFETY:

Chief Esser provided the monthly police report, citing 3 traffic reports, 2 criminal reports, 20 incident reports, 12 traffic citations, 1 criminal citation, 111 house checks, 27 beach checks, and 96 park checks. The chief also informed residents that Tim Marks, who had worked in the Timberlake Police Department for 8 years and as an officer, for 40 years, had decided to retire. He will be serving as an auxiliary civilian officer for the Village. Ms. Parihar introduced Resolution 2015-52, confirming the appointment of Timothy Marks on probationary basis to the position of auxiliary patrolman in the Village.

Motion to approve without changes or corrections: Parihar

Seconded: Gasier

All were in favor of the Resolution; Motion approved

Mr. Marks was sworn in and congratulated on his new role.

Ms. Parihar introduced Resolution 2015-53, confirming the promotion of patrolman Peter Krause from pay class 7 to pay class 6 in the Village.

Motion to approve without changes or corrections: Parihar

Seconded: Sharma

All were in favor of the Resolution; Motion approved

SEWERS

Mr. Gasier says there have been no reports of floods or other concerns as of late by the Village.

SERVICE

Per Mr. Stanton, the truck arrived today, but the rear-end is rusting out, so abrasives were needed to weld the area in order to make it functional. Plows will be tested this week, as well. Leaf pick-up has begun and it is recommended to collect all leaves by 11/27. Residents were also reminded to get trash out prior to 6 AM. The Water Department came in as well to break old concrete and get new risers for the manholes. The Mayor did send a letter to ODOT to stretch the berm on Lake Shore and is waiting to hear back. Mr. Stanton will be attending a Pavement Presentation Lunch and Learn seminar in order to learn how to upkeep the roads. Pete

Formica conducted a cost assessment for sealing the roads, which will be necessary in a few years, and estimates \$40,000 to \$60,000.

VILLAGE HALL

Dr. Sharma attended the Lake County Emergency Operations meeting in order to identify hazards that Lake County may be susceptible to. She was also able to purchase a carpet cleaner, originally quoted for \$1600, for \$800. The exit signs are now fixed in the Village Hall, as well.

PARKS & TREES

The Mayor informed residents that one tree did come down about a week ago which will need to be tackled by the tree removal project for next year.

FINANCE

Mr. Dicki presented Ordinance 2015-25, authorizing the transfer of funds from A01-3-A-211 playground wages fund appropriation to the A01-5-G-211 tree/service wages fund appropriation. He then motioned to suspend the three reading rule for Ordinance 2015-25.

All were in favor of suspension of the rule. Motion to approve Ordinance 2015-25: Dicki

Seconded: Stanton

All were in favor of the Resolution; Motion approved.

Mr. Dicki presented Ordinance 2015-26, authorizing the transfer of funds from A01-5-F-230, rubbish contract fund appropriation to the A01-7-B-215 council secretary's wages fund appropriation. He then motioned to suspend the three reading rule for Ordinance 2015-26.

All were in favor of suspension of the rule. Motion to approve Ordinance 2015-26: Dicki

Seconded: Parihar

All were in favor of the Resolution; Motion approved

Mr. Dicki presented Ordinance 2015-27, establishing a receipt account for property taxes receipt account for homestead reimbursements in the "Capital Road Project" fund for the Village. He then motioned to suspend the three reading rule for Ordinance 2015-26. The Fiscal Officer explained that this establishes the receipt accounts to transfer money to capital funds to pay interest on note.

Mr. Dicki presented Resolution 2015-54, approving and directing payment of certain bills by the Village.

All were in favor of the Resolution; Motion approved.

The Mayor asked for a motion to adjourn the meeting at 8:10 PM.
