#### TIMBERLAKE COUNCIL MEETING June 18th, 2019

The Mayor opened the meeting with the pledge of allegiance followed by the public portion at 7:30 PM. He asked for roll call of the officers. All council members were present along with the fiscal officer and the solicitor, Mr. Germano. The Mayor stated August 7<sup>th</sup> is the deadline for anyone that wants to run for the upcoming elections. By September 4<sup>th</sup>, residents can sign up as write-ins. The Mayor would also like to have the Villagers vote on the ordinances, letting majority rule. The first Sunday in August is the Village Picnic, which is a great opportunity to meet current and new neighbors.

The Mayor asked for a motion to approve April 16<sup>th</sup> Council Minutes.

Motion carried; Minutes approved.

#### **PUBLIC PORTION**

A resident thanked the Mayor for putting the ordinances up for vote. She also asked if the zoning inspector and police officers can work toward

increasing relations within neighbors in the Village. She would like the officers to survey the area and see the issues that occur on properties and proactively deal with it rather than have neighbors reactively complain about the problems. Another neighbor asked how as a villager he should handle antagonistic neighbors that are loudly complaining in the community. The Mayor urged that neighbors should resolve rifts amongst each other. If there is a legal issue, the police should be consulted. He also says he hopes people will have the common sense of not being rude to one another. Another resident stated she is unsure why people have dogs out all day and all night long. Another resident asked if there is a police officer to direct partygoers; the Mayor stated the police officers are there, but the guests tend to not listen. She also asked if there can be a sign that states guests cannot be at the park after dusk. Another resident asked why 10-12 checks were bounced in January. She also asked if the dog laws can be included into the Timberlake Times. The Mayor will pass on the suggestion to the editor. Another resident also stated he hears people at the park at 11:30 PM through the windows in his home and that police officers need to survey the area. Another resident asked if illegal dumping by the park will be addressed and if the park field will be cleaned up. He also asked if there is a fine for dumping trash in the resident. He also asked about the tree stump removal by Village Hall. He asked about if money has been recouped by Ciro's on work they did not complete. Lastly, he stated a bunch of the catch basins were covered in the last rain. Another resident gave kudos to the Sunday officer that set up the cones on either side of the fire hydrants. Another resident asked if a piano can be placed in the hall, as she has one to donate. There were 2 no's and 3 abstains. The Mayor said that as people do not respect the property here, he doesn't want to risk it breaking. Another resident asked about what happened to the "Slow, Children" sign that was by the west end of

the Village. Ms. Laub said the signs were moved closer to the parks. The resident asked if this was confirmed with a safety officer as he feels it is better to be at the area where people enter the Village. The Mayor asked to address this in the next safety meeting. Another resident asked what the protocol is for having beach guests. Will there be a fine or warning list of people who come to the beach, but are not allowed to? He also asked about where the signs for protecting the baby grass was. He also asked if the Mayor can ask the Village Club to not have anyone drive across the Village Hall vard, as it ruins the mulching and the grass. Another resident thanked Linda for her hard-work on the hall. The Mayor also confirmed there will be a parade this year and the North Marching Band will be marching, as well. The resident asked if anyone discussed about the "Police Only" parking sign.

#### **SAFETY**

Mr. Cronin stated the "Police Only" sign will not be removed. None of the other residents have an issue with the police officer sign. Mr. Cronin congratulated the new police officers for their service and stated there will be a resolution to reduce the sergeant pay from \$14 to \$11/hour in order to increase the pay for patrolman. He also stated that a resident will be willing to be a part of the auxiliary police force. He said residents are welcome to join this force and it is minimal training. He also informed the residents that many new officers will be hired, and they will be proactive in identifying beachgoers. Since they are new, they will be asking most beachgoers who they are. Ms. Murphy said everyday there is a gentleman who comes to the Village between 2-4 PM. He has been ticketed, but still comes. She says people have called her about where the police officers are.

Chief Tryon said issuing three cards to each resident with their names and addresses, that way it showcases that they are legally on the beach. He stated this is very inexpensive and a fairly easy solution. The Mayor asked how much it will cost and when it can be done. An officer volunteered to do that. The chief volunteered to pay for the toner and copy machine. Ms. Laub asked if residents will come to sign a paper, when they pick up the card to confirm. The Chief also said they will start to shut down the park at dusk and have officers at the park

during that time. The Chief also said that dogs have to be barking for 15 minutes in a continuous manner for the officers to address it. He states that there is no ordinance forbidding dogs from being outside as long as they have water and shelter. The new policy is that if the dog is barking more than the 15 minutes, the first time is a warning and the second time is a citation. This will be logged by the police officers. The Chief said residents should call the Lake County central number if there are contractors ruining their yard. The Mayor said he will put that number in the Timberlake Times. Ms. Murphy said there was a brawl here on Saturday as the cones were not put away. The Chief was under the impression that the cones were to be put away by the Service Department. He said he will review this in the future and ensure it doesn't repeat. She said she came to the Hall a few nights ago and there were no lights on in the police department or in the Hall. An officer stated sometimes the lights do come on and sometimes they don't. A resident explained where the lights were, and the Mayor suggested putting in automatic LED lights. The Chief also addressed the yard waste dumping issue; he stated if residents can tell the police officers when he is dumping the trash or if they can take a picture, that will make it easier to have evidence. The Chief said he will review it when he works on Thursday Morning. The Mayor gave the Chief the comments by the residents that the police officers building inspector's efforts become and coordinated. The Chief presented the police report for the past month. There were 174 logged activities. There were 38 reports and 117 traffic stops. There were 37 house checks and 27 beach/park checks activities. There were 11 traffic enforcement details, 37 traffic stops, and 3 traffic cites.

Mr. Cronin presented Resolution 2019-19, confirming the appointment on a probationary basis of Raja F. Fattah to the position of Special Patrolman in the Village of Timberlake Police Department.

Mr. Cronin presented Resolution 2019-20, confirming the appointment on a probationary basis of Masai E. Brown to the position of Special Patrolman in the Village of Timberlake Police Department.

All were in favor of the Resolution; Motion approved.

Mr. Cronin presented Resolution 2019-21, confirming the appointment on a probationary basis of Kevin Oliver, Sr. to the position of Special Patrolman in the Village of Timberlake Police Department.

Motion to approve Resolution 2019-21: Cronin

Seconded: Marsh-Coleman

All were in favor of the Resolution; Motion approved.

Mr. Cronin presented Resolution 2019-22, confirming the appointment of Kyle Cawley to the position of Patrolman in the Village of Timberlake Police Department.

Motion to approve Resolution 2019-22: Cronin

Seconded: R. Sharma

All were in favor of the Resolution; Motion approved.

These individuals were sworn in and congratulated on their new roles.

Mr. Cronin presented Ordinance 2019-18, amending pay schedule for Sergeant of Police Department for the Village.

Motion to suspend the 3<sup>rd</sup> reading rule: Cronin Seconded: S. Sharma

All were in favor of the Ordinance; Motion approved.

#### VILLAGE HALL

She stated the kitchen was painted and new flowers were planted. She thanked Mr. Peterson for his hard work. She said the bathroom and accessories still need to be addressed. She stated there are currently two websites for the Village Hall; she will ask the editor to put the current rates of the Hall into Timberlake Times as the website rates do not match.

#### TREES & RECREATION

Ms. Marsh-Coleman stated that to remove 5 trees, she received a quote for \$2950. The Mayor suggested contacting Orion about their day rates. The Mayor asked to check the prices on the stumps, as well, and give a total.

#### **SEWERS**

Ms. Sharma asked if Mr. Germano sent a letter to Ciro's. He said he was not given this information and will look into it. Both Ms. Laub and Ms. Sharma have spoken to Tony at Ciro's without any resolution. Alex does have footage of them missing basins. There is one catch basin in Waban and 3-4 basins on Eastshore with issues. Wyattworks quoted the Village a day job for jetting and cleaning out 4-5 sewers. She was quoted a rate last month and compiled all of the problem areas in Timberlake. There are some catch basins that are not stable with cones over them; she is in the process of getting quotes for those areas as it is expensive since the foundation needs to be replaced. The quotes vary between \$500-\$7000 per basin. There is one major and 2 minor ones, where the entire system needs to be rebuilt, while the other are grate issues and a cracked foundation. Mr. Cronin asked if there will be a representative watching the contractors do their work. She said a service member will be there and homeowners will be notified. The Mayor said he will contact Pete Formica about the drainage in the park field. Ms. Sharma stated the Village is in quite a rainy season and request villagers are patient with the drains during this time. She emphasized she is unable to help with private sewers and toilet issues. She asked that residents contact council members if there is an issue with Timberlake employees rather than directly yelling at those individuals. The Eastlake Eagles Erie Watch contacted Ms. Sharma to come to the beach to take pictures; Charles

Anderson will be here for a few minutes every couple of minutes to take the pictures of the eagles early in the morning. She informed the police officers of this, as well.

Ms. Sharma presented Resolution 2019-23, authorizing the Mayor to enter into a contract with Wyattworks for sewer work in the Village for a day job. This is for cleaning, jetting, televising, and locating sewer lines and structures at \$3339.00. They will give a warranty for their work, as well. They are very prompt about replying to the Village and are paid after the work is done, which was an issue with Ciro's.

Motion to approve Resolution 2019-23: S. Sharma Seconded: Murphy

All were in favor of the Resolution; Motion approved.

#### **SERVICE**

Ms. Laub stated she wanted to clarify April Minutes. She said service is not over-budget or out of money. Last year's front-end loader repair came out of the wrong budget, which is why it was showcasing incorrectly. The Village has been updated by the Service Department and the signs were moved by the parks and playgrounds. New signs were added to the beach today. She emphasized that guests must be accompanied by the residents. She also said that driveways are not allowed to be blocked by contractors and they cannot park in the islands. She thanked all the volunteers for the past couple of months who donated flowers and time in adopting and cleaning up the islands.

#### **FINANCE**

Dr. Sharma presented Resolution 2019-24, approving and directing payment of recurring bills by the Village.

Motion to approve Resolution 2019-24: R. Sharma Seconded: S. Sharma

All were in favor of the Resolution; Motion approved.

Dr. Sharma presented Resolution 2019-25, requesting county auditor certification pursuant to ORC 5705.03(B). This is for a levy on the ballot

this November, as it was not submitted last year. The financials were reviewed in the past year, which is how the levy was found. The lion share, 55-60%, will go into police and fire, per the Mayor. He stated he looked at property taxes, city taxes, and payrolls. He said the Village has several retirees, but young people are moving into the village. This levy will generate funds for the Village, approximately \$125000 in the next five years per the Mayor. That number will be confirmed next month by the County Auditor. The county will review the levy before it is on the ballot. This hasn't occurred for over a decade. He will also be ensuring that fund letters are being sent out by the solicitor for residents who are not paying their taxes. He says the council members are looking into everything they can to save money and maintain the current equipment. Chief Tryon said now Village members may lose their trash cans, so residents need to be careful that others are not throwing trash into their bins.

Motion to approve Resolution 2019-25: R. Sharma

Seconded: Laub

All were in favor of the Resolution; Motion approved.

The Mayor said he received a bittersweet email today. Michael Germano will be leaving his law firm and work with the Ohio Attorney General's office. He stated the law firm will continue to represent the Village and it was an honor working with the residents, police department, and the council. He said he has been with the firm for 31 years and appreciates working with the Village. The Mayor thanked him for his hard work as well as for going above and beyond for the Village.

Ms. Laub presented the following ordinances and placed it on second reading:

Ordinance 2019-03, amending section 302.10, outdoor materials and temporary structures, of the codified ordinance of the Village. They changed the language to outdoor materials and asked to move/dispose of any items outside that can attract vermin. There was a section added to address portable storage containers, which will now have a limit of 30 days of being placed outside.

Ordinance 2019-04, amending section 470.10, parking and storage of recreational vehicles, of the codified ordinance of the Village. It was changed to state any vehicle can be parked or stored in any enclosed area and RVs/boats must be stored in the rear, not the front. It was added that boats under 25 feet of length can be parked from June 1st to October 15th. RVs including boats have to be 25 feet or under. Mr. Cronin stated he is concerned that the Village is being turned to a home owners' association rather than a tight-knit community. He doesn't believe it is right that residents with 26 feet vehicles cannot be allowed to store it on their property. He thinks these ordinances should be posted in the Times and gain feedback from the residents in regard to this. Ms. Laub said this is an accumulation of 5-6 months of work and it is the Council's responsibility to gain the residents' opinion. Ms. McCarty said most of this language was already in the ordinances, the language was just tweaked to be clearer. It was also reviewed based on ordinances from surrounding cities. This ordinance will go to ballot.

Ordinance 2019-05, amending section 1260.09 building and setback lines; porches; vegetation; fences of the codified ordinance of the Village. It was added that shrubs, foliage, and fences must be maintained. It was also added that fences must be maintained in a functioning and safe condition.

Ordinance 2019-06, amending section 1060.01, placement and storage of trash containers of the codified ordinance of the Village. All that was added here was recycle and yard waste. The remainder is the same.

Ordinance 2019-07, amending section 470.09, parking of commercial vehicles of the codified ordinance of the Village. "With company markings, logos, or advertisements" was added. A villager suggested including this ordinance on the ballot, as well.

Ordinance 2019-08, amending section 1064.01, rental of Village Hall of the codified ordinance of the Village. The wording was changed to clean up the ordinance's language, as it was bulky originally.

Ordinance 2019-09, amending section 1064.02, rental of the Village Hall pavilion of the codified ordinance of the Village. The verbiage was changed here, as well, in a similar fashion as 1064.02.

Ordinance 2019-10, amending section 1062.03, minors of the codified ordinance of the Village. The language was changed so that children will not be allowed at the park all night.

Ordinance 2019-11, amending section 1062.05, miscellaneous regulation of the codified. It was added "outside of hours between dawn to dusk" and "use profanity to include musical lyrics."

Ordinance 2019-12, amending section 452.03, prohibited standing or parking places of the codified ordinance of the Village. This had older verbiage that was irrelevant to the Village, so needed to be changed.

The Mayor disbursed tentative budget schedules with financial information to each department for their respective areas. He adjusted it in accordance with the past budgets from 2016 and 2017. July 9<sup>th</sup> will be the next meeting; it will be at 6:30 for the finance meeting, then the council meeting. The council secretary will be out of town during that meeting, so it will be video recorded, and she will transcribe accordingly. The Mayor also stated residents are not allowed

The Mayor asked for a motion to adjourn the meeting at 9:21 PM.


