### TIMBERLAKE COUNCIL MEETING

May 21<sup>st</sup>, 2019

The Mayor opened the meeting with the pledge of allegiance followed by the public portion at 8:15 PM, as not all council members were present at 7:30 PM. He asked for roll call of the officers. All council members were present, except for Ms. Laub and the council secretary, who recorded the Minutes based on video footage of the meeting. Mr. Germano was initially present, but left prior to the onset of the meeting, which occurred at 8:15 PM. The Mayor stated that he recommends tabling the ordinances and postponing to next month.

The Mayor presented Ordinance 2019-13, authorizing the transfer of funds from the maintenance equipment fund, B01-6-B-235 to the supplies and materials fund, B01-6-B-240. He states that \$3,807.15 was allocated to the incorrect account, so this is the correction.

Motion to approve Ordinance 2019-13: S. Sharma  
Seconded: Murphy

All were in favor of the Ordinance; Motion approved.

### SAFETY

Mr. Cronin presented Resolution 2019-12, confirming the final appointment of Stephen Tryon to the position of Chief in the Village of Timberlake Police Department, satisfying his six-month probationary period.

All were in favor of the Resolution; Motion approved.

Mr. Cronin presented Resolution 2019-13, confirming the probationary basis Kyle Cawley to the position of Auxiliary Patrolman in the Village of Timberlake Police Department.

Motion to approve Resolution 2019-13: Cronin  
Seconded: S. Sharma

All were in favor of the Resolution; Motion approved.

Mr. Cawley was sworn in and congratulated on his new role. The other officers were unable to attend due to prior shifts.

The Mayor stated that Chief Tryon was able to recruit new officers even in a difficult market and thanked him for his service. He stated that most officers who train with Timberlake become a hot commodity. Mr. Cronin said the Village recently lost 4 officers to University Hospitals. The Mayor said there are four officers that will be sworn in today.

Mr. Cronin presented Resolution 2019-14, confirming the probationary basis Soul Llamas to the position of Auxiliary Patrolman in the Village of Timberlake Police Department.

Motion to approve Resolution 2019-14: Cronin

All were in favor of the Resolution; Motion approved.

Mr. Cronin presented Resolution 2019-15, confirming the probationary basis Jason Mazzaro to the position of Auxiliary Patrolman in the Village of Timberlake Police Department.

All were in favor of the Resolution; Motion approved.

Mr. Cronin presented Resolution 2019-16, confirming the probationary basis Fredrick Swanson to the position of Auxiliary Patrolman in the Village of Timberlake Police Department.

All were in favor of the Resolution; Motion approved.

Mr. Cronin presented Resolution 2019-17, confirming the probationary basis Michael Hribar to the position of Auxiliary Patrolman in the Village of Timberlake Police Department.

Motion to approve Resolution 2019-17: Cronin  
Seconded: S. Sharma

All were in favor of the Resolution; Motion approved.

Mr. Cronin presented Ordinance 2019-15, authorizing the transfer of funds from the Police Expense Appropriation to the Police Car Acquisition Appropriation fund. When the car was leased last year, the payment on the vehicle was \$6489. The Village puts in \$5000 per year, and it is due on June 12<sup>th</sup>.

All were in favor of the Ordinance; Motion approved.

Mr. Cronin presented Ordinance 2019-16, authorizing the transfer of funds from the backbone fund, A01-1-A-235 to the police expense fund, A01-1-A-240. Some of the bills were inadvertently taken out from the wrong account, so this ordinance is correcting that issue. The Mayor stated this way there will be a trail of the purchases, as well.

Mr. Cronin presented Ordinance 2019-17, authorizing the transfer of funds from the PSAP fund, A01-1A-234, to the police expense fund, A01-1-A-240.

All were in favor of the Ordinance; Motion approved.

### **TREES & RECREATION**

Ms. Marsh-Coleman stated there were no issues last month with trees. She is being careful as her budget is low.

### **SEWERS**

The Mayor spoke with Pete Formica about the Eastshore sewer lines. There is a section that always backs up due to smaller lines. The Mayor said there is a resident who is constantly contacting the Mayor about this issue. Pete will look into this; the Mayor said he would like to not spend the entire budget on just one yard. A few thousand dollars were already spent in that region. Ms. Sharma said she had WyattWorks come out to quote the job. There was a man who said for \$3339, he will come out for the day, jet the entire line as there were blockages by 75 Eastshore. In addition to this, the individual will also take care of other blockages in the Village the same day. This is a temporary fix but should last for a year. Ciro's has been contacted about returning the money the Village spent on jobs that they did not follow through with last year. Mr. Germano is pursuing this. A resident watched WyattWorks and saw them work on about 200 feet. Ms. Sharma stated they were hired for about 100 feet, so they did perform the job. A resident asked why the service department cannot complete the jetting, and the Mayor said he will look into this.

### **FINANCE**

Dr. Sharma presented Resolution 2019-18, approving and directing payment of recurring bills by the Village.

Motion to approve Resolution 2019-18: R. Sharma  
Seconded: S. Sharma

All were in favor of the Resolution; Motion approved.

The Mayor said the county system will be converted to the state system. The Fiscal Officer went to a training class last month. Another local fiscal officer has offered her services to help Mrs. Transky convert the files; she offered a rate of \$30/hour. The Mayor said there is a budget for this expense, which is why he is presenting it to council. It is estimated to take 8 hours. The Mayor went through the bills from last year and made corrections for the state. The financial report and a copy of the budget is present with the Mayor if any council members would like to look at it. \$70,000 was in payments to Eastlake for the Storm Water Project, which was agreed upon in 2006. By updating Mrs. Transky with the correct system, the audits will be easier and hopefully, less time consuming. Mrs. Transky noted that this individual has been on the UAN system for a very long time

and was hired by them, so she is knowledgeable. The Mayor asked about her in other communities, and the mayors there stated that “this woman keeps us honest”. Therefore, he recommends proceeding with this charge. He wanted to inform the council so they were aware, as Mrs. Transky has the ability to authorize the payment.

The Mayor asked for a motion to adjourn the meeting at 8:55 PM.
