#### TIMBERLAKE COUNCIL MEETING October 16<sup>th</sup>, 2018

The Mayor opened the meeting with the pledge of allegiance followed by the public portion at 7:30 PM. He asked for roll call of the officers. All council members were present along with our Solicitor, except for Shannon Sharma, who is out of town; the fiscal officer was not in attendance. The Mayor stated that there will be a haunted house this year at the Village Hall through the Village Club. Please contact the Village Club if you're able to help volunteer.

The Mayor asked for a motion to approve September

18<sup>th</sup>, 2018 Council Minutes.

Motion to approve: Marsh-Coleman

Seconded: Murphy

Ayes: Murphy, Cronin, Marsh-Coleman, Laub, R.

Sharma, and S. Sharma.

Nays: None

Motion carried; Minutes approved.

#### **PUBLIC PORTION QUESTIONS**

There was a question about the contract with Ciro's in regard to why the Village doesn't have the Service Department clean out the basins.

#### **SAFETY**

Mr. Cronin presented Resolution 2018-40, confirming the appointment on a probationary basis of Stephen M. Tryon to the position of Chief of Police in the Village of Timberlake Police Department. Chief Esser accepted employment elsewhere so the Village interviewed four very qualified candidates and the hiring panel selected Chief Tryon.

Motion to approve Resolution 2018-40: Cronin

Seconded: R. Sharma

All were in favor of the Resolution; Motion approved

Chief Tryon was sworn in and congratulated on his new role. He introduced himself to the Village and his hopes for the police department. He welcomes comments, concerns, and issues from village residents. Mr. Cronin said this role will be administrative only and the pay is being dropped drastically to open up more spots for paid patrolmen. The Mayor stated that by serving this role, the Chief will be more accessible to Village members. He stated the phones are also fixed at the police department. Mr. Cronin thanked the hiring committee for holding the interviews.

Mr. Cronin presented Ordinance 2018-12, amending Ordinance 2018-11, amending the pay schedule of the Chief of Police. He explained the salary for the new Chief will be an \$800 biweekly stipend based on 20 hours a week. He is not required to work any shifts on the road, but if he would opt to, he will be paid the same as the other officers at \$9/hr. That is a \$19200 reduction from the prior Chief's salary.

Motion to suspend third reading rule: Cronin

Seconded: Murphy

Motion to approve Ordinance 2018-12: Cronin

Seconded: Laub

All were in favor of the Ordinance; Motion approved.

Mr. Cronin recommended having an ordinance review board to with the participation of residents to amend and look into the current resolutions. Ms. Laub and Ms. Marsh-Coleman volunteered to be part of the committee. Residents interested in being on the committee can contact these individuals.

Officer Clarich presented the monthly report for both August and September. In August, there were 31 reports, 20 citations, 67 house checks and 47 community policing activities totaling 286 activities. In September, there were 33 reports, 20 citations, 107 house checks and 35 community policing activities totaling 303 activities.

#### **VILLAGE HALL**

Ms. Murphy stated that rentals have slowed down, which is normal for this time of year. She asked if the police department could review the tape outside as some residents are getting blocked from leaving their

garages. Mr. Cronin said cones are being ordered to replace the tape. She asked about the voicemail for the police department, which will be set up this week. She also asked if the chairs can be returned and the lights turned off after any meetings. The lock on the front door has had to be fixed too. She also spoke to Pete Formica and is talking to Bob Smith's electrician. She is looking into quotes for the LED lights as the Village received grant money. It's approximately \$3000/year. The Mayor stated he'd like to have this done before the end of this year and has spoken to Mr. Formica in regard to this. He hopes to also have lights outside, including by the bocce court and the gazebo to enhance the area. Ms. Murphy said the floor was also redone and chairs/tables should not be put on it. There are already some scratches on it which requires rebuffing.

#### **SERVICE**

Ms. Laub stated the Service Department has been able to maintain the grounds well. The service motor is out of service but is being fixed by Bob Smith. Eastlake will be helping the Village with salt storage. Mr. Cronin is waiting on the agreement from the City of Eastlake. That will help with not utilizing the dilapidated salt shed. The Mayor said the price that was quoted is less than what it was last year. There won't be a 5 to 7-day lag either, which will help us remain stocked. The invoice will be sent every month, which is more economical. Ms. Laub said equipment repairs due to budget limitations will be posted by next year. She also received quotes for 36 street signs, which have to adhere to the state guidelines. The quotes are between \$1200-\$1800, including a logo. She brought samples of the logos and asked residents to select which ones they like. The turnaround time is 30 days. Furthermore, wood is currently being collected. She also had a sign-up for residents who want a bundle of wood for residents. They will be at the service yard to be picked up.

#### TREES & RECREATION

Ms. Marsh-Coleman said a lot of tree work was done last month. The wood is being cut up right now and the stumps being grinded down. The Lake County Community Cats program is tomorrow night, so she requested the presence of residents to stop by if they are interested at 7 PM. The playground is still being worked on.

#### **SEWERS**

The Mayor stated that the Village does not have a set contract with Ciro's, but they are used more often as we have worked with them before. Ms. Sharma is looking into other quotes, as well. Ms. Laub is working with the Mayor in regard to having the Service Department clean the basins, especially as it will be more cost-effective.

#### **FINANCE**

Dr. Sharma presented Resolution 2018-41, approving and directing payment of certain bills by the Village. Motion to approve Resolution 2018-41: R. Sharma Seconded: Laub

All were in favor of the Resolution; Motion approved.

Dr. Sharma presented Resolution 2018-42, accepting the amounts and rates as determined by the Budget Commission and authorizing the necessary tax levies and certifying them to the County Auditor. The Mayor clarified that the budget was reviewed by the auditor and this resolution is a response to their feedback. It has to be verified, approved, and resent to the County Auditor.

Motion to approve Resolution 2018-42: R. Sharma Seconded: Marsh-Coleman

All were in favor of the Resolution; Motion approved.


